Students for whom English is not the primary language must demonstrate adequate English skills by submitting a minimum TOEFL score (550 paper, 213 computer), an SAT verbal score of 480, an IELTS score of 6, or a grade of "C" or better on a freshman-level English course completed at a regionally accredited U.S. institution.
- d. Students unable to satisfy this English requirement may wish to attend NSU's Intensive English Program. Call for details.
